The Minister of Finance,

- Considering Law N°05-01 of 27 Dhou Al Hidja 1425 corresponding to 6 February 2005 pertaining to the prevention and fight against money laundering and terrorism financing, as amended and supplemented, particularly Article 18 bis 2,
- Considering Presidential Decree N°17-243 of 25 Dhou El Kaada 1438 corresponding to 17 August 2017 related to the appointment of members of the government,
- Considering Executive Decree n°02-127 of 24 Moharram 1423 corresponding to 7 April 2002, amended and supplemented ,establishing the organization and functioning of the Financial Intelligence Processing Unit (CTRF),
- Considering Executive Decree n° 15-113 of 23 Rajab 1436 corresponding to 12 May 2015 related to the procedure of freezing and/or seizure of funds and assets within the framework of prevention and fight against terrorist financing,

Orders the following:

Article 1: Funds and assets of persons, groups and entities subject of sanctions decided by the UN Security Council, pursuant to Chapter VII of the United Nations Charter and in accordance with Security Council Resolution 1267 (1999), 1989 (2011), 2253 (2015), 1988 (2011) and 2255 (2015) and its subsequent resolutions, whose list was updated on August 23, 2018 on the website of United Nations Security Council and the website of the Financial Intelligence Processing Unit (CTRF) joined to the Annex of the original hereby Order, are frozen and/or seized without delay.

Article 2: The publication, on the official website of the Financial Intelligence Processing Unit (CTRF) of the hereby Order as well as the United Nations Security Council list which is appended to it, updated on August 23, 2018, is tantamount to notification to the obliged persons of freezing and/or seizure order without delay of funds and assets of persons, groups and entities on the said list.

Article 3: The President of the Financial Intelligence Processing Unit (CTRF) is in charge of implementing the provisions of the hereby Order as well as the appended list which is updated to the present day
